Summary Narrative

The Garrison School considers sustainability a fundamental principle. Spanning nearly 200 acres, the school campus provides abundant space to impart meaningful sustainability education. Our Pre-K-12 Youth Climate Summit unites the entire community, exposing students to experts and allowing them to present their ideas. The District demonstrates a robust dedication to educating every student about the significance of the environment. Guided by our Coordinator of Environmental Education, Rachel Arbor, and supported by teachers, students engage in multidisciplinary curricula, citizen science, STEAM, and civic action, seamlessly integrating environmental literacy across all grade levels and content areas.

Pillar I Narrative

Garrison School has made significant strides in environmental stewardship, particularly in Pillar 1 of the Federal Green Ribbon award, focusing on reducing greenhouse gas emissions. Through a \$10 million capital bond project, the school successfully transitioned from oil-powered boilers to fully electric air-forced heat pumps and is eliminating its gas-powered hot water heaters. The community approved these changes, aligning with the EPA Portfolio Manager to track and optimize electricity usage, demonstrating a commitment to renewable energy sources. The District is also investigating solar as a further option for renewable energy.

The District also used bus route planning software for the 23-24 school year. This program allowed the district to maximize the routes and thus eliminate one of its buses. The District has a well-publicized no idling policy for buses in accordance with New York State Education Law and all other vehicles. "No-Idling" signs are posted for all buses vehicles. 15% of the students walk or bike to school or carpool. The other 75% ride the school buses or take public transportation. This helps eliminate additional vehicles on the road. The district has established Safe Pedestrian Routes to school which are distributed to parents/guardians and posted in the main office. The District has a pedestrian crosswalk with a crossing guard in front of the school for our walking students. Sidewalks are maintained by the town and the school. These efforts help provide safety to the students during their commute to school and back home. The district also provides a sufficient number of bicycle racks for the students.

The district adheres to green building standards certified by the EPA, utilizing the Energy Star Portfolio Manager for energy efficiency. The Garrison School employs occupancy sensors for lighting and follows set schedules to minimize energy consumption during unoccupied times. Renovations included energy-efficient features like low-flow toilets, water bottle refill stations, and 90% LED lighting, significantly reducing water and energy usage. The extensive renovation project encompassed every facet of the school building, resulting in an environmentally friendly structure. Installing LED lighting, refillable water stations and motion sensors significantly increase energy efficiency. Partnerships focus on education, showcasing the school's commitment to sustainability.

The school takes pride in its expansive 181-acre forest, utilized for research and recreation, reflecting its dedication to ecologically beneficial practices. Landscaping initiatives prioritize water

efficiency, regionally appropriate plants, and the transition to electric landscaping equipment. The school specifically chooses plants for its landscaping that can thrive without excess water usage, meaning 100% of the landscaping is water-efficient. Similarly, 100% of landscaping at Garrison School is regionally appropriate and no plants at the school are considered to be among invasive species in the region. As a result, an irrigation system is not required, saving substantial amount of water. The District is also in the process of transitioning away from gas powered landscaping equipment and moving to electric.

Garrison School prioritizes water conservation, with automatic faucet shut-offs and eliminating bathroom paper towels. Lead control measures surpass state requirements, including installing stainless steel faucets and regular testing. Green procurement policies ensure environmentally friendly custodial, maintenance, and instructional products. The District has a recycling campaign that has reduced the amount of garbage by half and increased the amount of recycling by 6%. All the District's paper content is post-consumer material or fiber from forests certified as responsibly managed by the Forest Stewardship Council, Sustainable Forestry Initiative, American Tree Farm System or other certification standard. All the District's paper content is also totally chlorine-free (TCF) or processed chlorine free (PCF). The District also uses "third party certified" green cleaning products as listed on the New York State Office of General Services approved product list.

Pillar II Narrative

Garrison School is steadfast in environmental health, aligning with Pillar 2 of the Federal Green Ribbon award. Mr. Joe Jimick, the IAQ coordinator, oversees a comprehensive environmental health program that includes a new HVAC system with clean-running air source heat pump technology and MERV air filters. The school has written plans covering emergency response, integrated pest management, respiratory protection, chemical hygiene, and safety.

The school places a particular emphasis on supporting students with asthma, providing training for staff members, and maintaining an on-site registered nurse for guidance. Asthma management plans developed collaboratively with students, parents, and healthcare providers are in place. The school takes various measures to reduce exposure to asthma triggers, both inside facilities and on school grounds. A coordinated approach to student health is evident through a coordinated school health initiative. The school has a local wellness policy and an active committee addressing critical components of student health.

The Physical education program provides many opportunities for outdoor supervised physical education. From September to November and Mid-march until late June, classes are held outside, weather permitting. The PE program meets or exceeds the minutes requirement for physical education, depending on the week. With the vast forest and grounds, classes also go outside at other times. The District also partners with the Garrison gardening club to learn more about local plants in the area. The Garrison Gardening Club also shows our students how they take care of the different gardens around the school. The local community Garrison Gardening Club takes care of the plants and flowers when needed.

The District does not have a lunch program since the students bring their own lunches (driven by community input). The District provides education to the student on healthy choices and provides healthy meals when lunch is provided. The District continues to explore options for incorporating healthy food choices into the school.

Furthermore, The Garrison School is committed to the safe use of chemicals, adhering to state mandates for training, spill response, and hazard communication. A detailed chemical hygiene plan guides chemical purchasing, training, spill response, and safety procedures, with staff members undergoing annual Right to Know training.

The integrated pest management program emphasizes prevention through routine housekeeping and maintenance protocols. The Garrison School complies with state laws regarding pesticide use notification and maintains records of all pest-management activities.

The District has banned all cell phones during any class period. Garrison School actively promotes physical activity through a variety of initiatives. It participates in national campaigns such as the week-long "turn off televisions" campaign, providing students and families with information on reducing television and recreational screen time. Informative assemblies are also held, focusing on social media usage and the importance of daily limitations.

Garrison School is committed to fostering students' mental well-being and cultivating a nurturing and empathetic school atmosphere. To achieve this objective, the school maintains a team of one school counselor, one full-time school psychologist, and a consultant school psychologist, all readily available to offer support and guidance to students. Moreover, the school regularly hosts a series of anti-bullying initiatives and fully adheres to the state's Dignity for All Students Act requirements. The school has implemented the RULER program in all grade levels. Several of the teachers are trained in Dialectic Behavior Therapy (DBT) to help students work through issues. The District also has a monitoring system on all devices that alerts the administration whenever any language that could indicate harm to a student is used.

Pillar III Narrative

The Garrison Union Free School District (GUFS) is committed to Pillar 3 of the Federal Green Ribbon, aiming to nurture the next generation of environmentally conscious individuals. Rachel Arbor, the Coordinator of Environmental Education, plays a crucial role in this endeavor and actively integrates environmental education (EE) into the curriculum across all grade levels. Teachers' professional development ensures effective EE integration, while collaboration fosters the creation of interdisciplinary ecological content.

EE is seamlessly blended into the everyday curriculum at Garrison across all grade levels. Through science, students explore nature first-hand, yielding a holistic understanding of how our interactions with the environment shape our knowledge. In history classes, students learn how an ecosystem services mindset has influenced our trade programs today and how this historical perspective can help them take civic action today. Mathematics supports students in conducting quantitative analysis of the human-wildlife relationship, examining population trends of endangered species. English language arts help our students communicate their findings and establish a personal connection with our natural world.

The Garrison EE program strongly emphasizes achieving net-zero environmental impacts and underscores the connection between the environment and personal health. The Annual Youth Climate Summit serves as a platform for PK-12 students from various school districts and states to converge in the spirit of sustainability. Here, students share their long-term research projects, learn from experts in the field through hands-on workshops, and contribute to public discourse.

The school's expansive 181-acre forest serves as a classroom for place-based learning, so Garrison incorporates outdoor experiences into its curriculum. Using green spaces, students explore self-expression and personal narratives and delve into composting, climate change, indigenous perspectives, and biodiversity - all rooted in standards across disciplines. The Garrison School Forest also serves as a hub for citizen science, civic action, and STEAM-based learning, including projects like Carbon Sequestration and Forces and Motion in Nature.

Enriching the educational experience, guest speakers, local field experts, and participation in community events deepen students' knowledge of the local ecosystem and their role within it. From reusing materials through student-led clothing swaps to studying the effects of climate change on extreme weather, every PK-8 Garrison student is actively involved in various projects promoting civic action and environmental awareness.

When students graduate from Garrison, they leave with a profound understanding of their impact on the natural world and the importance of positive civic action. The curriculum's interdisciplinary connections provide a holistic learning experience, allowing students to explore, communicate, and connect with the natural world across subjects.
